## 3 Motorcycle Safety Tips for Extreme Heat

### Beat the Heat While Riding Your Motorcycle This Summer in Georgia

My son and I always look forward to riding during the summer. However, if you are an avid rider like us, you know that Georgia summers can be unbearable. The heat can also be life-threatening if you aren't careful. So here are a few tips to help you stay safe:

#### 1. Get a Breathable Helmet


One of the most important pieces of safety gear you own is your helmet, and Georgia Law requires that you wear one. However, you can switch to a helmet that will make riding more comfortable, even in extreme heat. The best summer motorcycle helmets are made of carbon fiber or polycarbonate and fiberglass hybrids, so they are light and breathable but still sturdy enough to offer the right protection.

#### 2. Stay Hydrated

As you ride, you will sweat, and your body will lose water. Therefore, you need to keep drinking water to rehydrate. You should drink about one liter of water for every hour you spend riding in hot weather. On long trips, stick to water. Drinking sugary or caffeinated drinks can actually dehydrate you.

#### 3. Stop Frequently

Taking frequent breaks during your trip is important because riders often fail to recognize that they are becoming tired or overheated. It is only when you stop that you realize how hot, tired, and thirsty you are. So, to ensure that you don't have a heat-related accident, take regular breaks.

The Winery is unique compared to other local wineries. They offer red and white wines and



## Recipe Cards from Readers

### Susan's Summer Cantaloupe Salad



### Salad Ingredients

- 1 cantaloupe, diced
- 1/2 English cucumber, thinly sliced
- 1/4 cup loosely packed mint leaves, julienned
- 1/4 cup loosely packed basil leaves, julienned
- 1 pint raspberries

### Dressing Ingredients

- 2 tbsp lemon juice
- 2 tbsp extra virgin olive oil
- 1 tbsp honey
- sea salt, to taste

### Directions

1. Combine the cantaloupe, cucumber, mint, and basil leaves in a large salad bowl.
2. In a separate bowl, whisk the lemon juice, extra virgin olive oil, and honey until the honey dissolves and the dressing is smooth.
3. Pour the dressing over the salad ingredients and toss until combined.
4. Garnish with fresh raspberries.
