Trained Police Officers Will Soon Be Able to Draw Blood from DUI Suspects

Georgia will soon have trained officers that can draw blood from drunk drivers, impaired drivers, or DUI suspects. It can happen on the spot of the actual DUI arrests. Over a dozen states have already enacted very similar laws, and by the end of 2021, the Governor's Office of Highway Safety expects to have close to 100 trained officers certified in phlebotomy.

The Georgia law enforcement community believes that this new program will provide evidence critical for prosecuting DUI cases. In addition to alcohol, the test can also check for illegal and prescription drugs.

For the officer to draw blood from the suspect, a judge must sign a warrant, or the DUI suspect must consent for the blood draw to occur. However, once a search warrant has been issued for a suspect's blood, the driver must give the sample. The officers are able to draw the blood from the suspects in a sanitary environment as chosen by the officers.

Law enforcement officials believe that all this new evidence will help prosecute cases even faster and more thoroughly. Additionally, many



officers feel that this new tool may be a deterrent to driving drunk if the person thinks the officers might be able to draw their blood at the arrest site.

Starting on October 4, 2021, the first group of officers will begin training to become certified. State troopers, HEAT officials, and Georgia State Patrol Nighthawk officers will be among the first to receive training.

Over the years, my law firm has handled a number of serious injury cases that were caused by drunk drivers, and I hope this new program truly does help reduce the number of DUI accidents and the lives they ruin.

Recipe Cards from Readers

Debbie's Super Easy Pumpkin Fudge



Ingredients

- 2 cups white sugar
- 1 cup brown sugar
- 2/3 cup evaporated milk
- 1/2 cup pumpkin puree
- 1 1/2 teaspoons cinnamon
- 3/4 cup (1 1/2 sticks) butter
- 1/4 teaspoon ground cloves
- 3/4 teaspoon ground ginger
- 1 1/2 teaspoons vanilla extract
- 1 jar (7 oz.) Kraft marshmallow crème
- 2 cups white chocolate chips, chopped

Directions

- 1. Start with a 9x9-inch baking pan (for thinner fudge, use 9x13 instead). Line pan with non-stick foil to make it easier to lift the fudge out of the pan.
- 2. In a medium saucepan, mix white sugar, brown sugar, pumpkin, butter, evaporated milk. Bring mixture to a full boil over medium heat, and stir constantly. Boil the mixture and continue to stir for about 5 minutes.
- 3. Take the saucepan off the heat and immediately stir in the marshmallow creme, white chocolate chips, and vanilla extract. Continue stirring the mixture until all the chocolate chips have melted. Pour into the baking pan and allow to cool for around 2 hours. Once cooled, cut fudge into 1-inch pieces to serve store pumpkin fudge in the refrigerator.
