All kidding aside, whether you are looking forward to Super Bowl Sunday, Valentine's Day, or both, I hope that you have the best day with the ones that you love.







Where the Law Meets Technology

Apple Wallet Will Now Let You Digitize Your GA Driver's License, But Should You?





A big, new feature coming to Apple's iOS in 2022 is that you will be able to store your driver's license and state ID cards in your Apple Wallet. Eight U.S. states have already signed up for digital IDs, including Georgia.

"This is a big step toward the next phase of personal identification. But, should you keep your ID on your iPhone?"

If you have your ID on your phone, you could likely breeze through TSA security lines, check-in at your doctor's office, or prove your age at a liquor store. Businesses or institutions could verify your identity from your phone in less than a second using an NFC scanner.

Another great benefit is that if someone steals your iPhone to use your ID, you can disable it remotely or potentially track where the fraudsters impersonated you to catch them more easily. Whereas if your wallet is stolen, you most likely will never see it again.

"So, what's the big deal?"

Convenience nearly always comes at a cost, and there is a danger that this creates opportunities for greater levels of surveillance. There are many unanswered questions about Subscribe

Apple, Google, and Facebook. One major issue is that identity documents will be easier to share, so businesses, government institutions, and websites may share them with 3rd parties without your knowledge.

If digital IDs become widely used, interactions with the government and businesses could also change. For example, would you let a police officer carry your phone back to their car? If companies begin asking customers for ID, will they turn you away if you don't own a phone? And what will happen when the government declines to authenticate your digital ID or notices you have an expired license?

Apple says that Georgia, Connecticut, Arizona, Iowa, Maryland, Kentucky, Utah, and Oklahoma will be the first states to let people use digital driver's licenses and IDs. So if you are an early adopter, you can use your digital ID at some TSA checkpoints, but you'll still need a physical ID in every other case while the rest of the world catches up with this technology.

Our Conclusion

For now, we can only guess how this technology will change our world. We do know that many people will use Apple Wallet to store their IDs but there will be many holdouts who want to see what the long-term consequences of it will be. So the question of whether you should keep your ID in Apple Pay is a personal one based on if you prefer convenience or privacy. Odds are that all IDs will eventually be digital and this is a step towards that direction, but for now, you still have a choice.

Since Apple is scheduled to release this sometime in 2022, I wanted to make you aware so that you can do your research

- 1-ounce Drambuie


Directions:

ABSURD Legal Cases You Won't Believe:

Love can hurt...your wallet?!



Love is in the air! It's almost Valentine's Day, so we thought we'd share this absurd lawsuit as a reminder that money can't buy love.

Here's the story of Joseph Bisignano, 66, of Des Moines, Iowa:

Joseph, a stockbroker who had previously been married three times prior, spent more than \$330,000 in an attempt to persuade Mary Toon, 54, to become his fourth wife. He lavished her with many high-priced gifts like a 9-carat engagement ring valued at \$75,000, artwork, a Vera Wang wedding dress, and paid her federal income taxes. One of the last extravagant gifts that Bisignano bought Mary was a \$4,045 fur coat. And then Mary ended it all two weeks later.

Joseph. She kept all of the gifts and the engagement ring. When Joseph tried to get some of the gifts and money back, Mary allegedly told him "that if he wants to be repaid...he should retain a lawyer." And that's exactly what he did.
